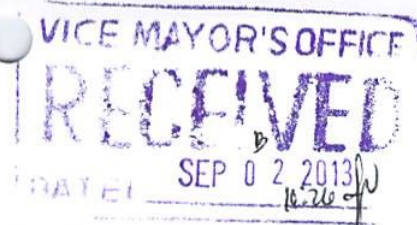

RESOLUTION NO. 2013-030

A RESOLUTION DECLARING THAT ORDINANCE NO . 03,
SERIES OF 2013 OF THE BARANGAY COUNCIL OF
BARANGAY DISTRICT 12, THIS CITY, UNDER REVIEW HAS
BEEN FOUND TO BE NOT IN CONFORMITY WITH R.A.
7160, ENTITLED: "THE LOCAL GOVERNMENT CODE OF
1991".

WHEREAS, the 13th Sangguniang Panlungsod ng Ormoc has received a
Barangay Ordinance No .03, Series of 2013 of the Barangay Council of Barangay
District 12, entitled: "AN ORDINANCE APPROPRIATING THE AMOUNT OF
PESOS : ONE HUNDRED SEVENTY THOUSAND PESOS (P170,000.00) TO
PROCURE/CONSTRUCT TEN (10) UNITS ROLLING STORE IN CONSONANCE WITH
THE LIVELIHOOD PROGRAM OF BARANGAY DISTRICT 12";

WHEREAS, the aforementioned Barangay Ordinance was submitted to this
Sanggunian for review as mandated in Section 57 of the Local Government Code of
1991;

WHEREAS, it is the observation of this august body that certain provisions of
the subject barangay ordinance are inconsistent with existing laws and ordinances
hence, needs to be modified and amended in accordance with the
recommendations contained in the Committee Report of the Committee on Laws
and Ordinances attached hereto and marked as Annex "A" of this resolution.;

Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, duly
seconded by City Councilor Tomas R. Serafica; be it
