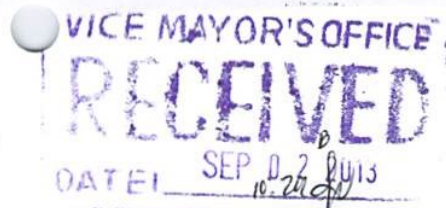

*A RESOLUTION DECLARING THAT BARANGAY ORDINANCE
NO . 01, SERIES OF 2013 OF BARANGAY JUATON IS NOT
WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG
BARANGAY TO ENACT.*

WHEREAS, this sanggunian is in receipt of Barangay Ordinance No .01, Series of 2013 of the Barangay Council of Barangay Juaton, entitled: "BARANGAY ORDINANCE ON THE PREVENTION AND ELIMINATION OF CHILD LABOR";

WHEREAS, the aforementioned Barangay Ordinance was submitted to this Sanggunian for review as mandated in Section 57, of the Local Government Code of 1991;

WHEREAS, it is the observation of this august body that certain provisions of the subject barangay ordinance are inconsistent with existing laws and ordinances hence, needs to be modified and amended in accordance with the recommendations contained in the Committee Report of the Committee on Laws and Ordinances attached hereto and marked as Annex "A" of this resolution;

WHEREFORE, foregoing premises considered, on motion of City Councilor Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, duly seconded by City Councilor Corinne M. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution DECLARING THAT BARANGAY ORDINANCE NO . 01, SERIES OF 2013 OF BARANGAY JUATON IS NOT WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BARANGAY TO ENACT;
