

RESOLUTION NO. 2013-032

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE LAND BANK OF THE PHILIPPINES FOR THE CITY TO AVAIL OF THE LANDBANK RFID-ENABLED CARD.

WHEREAS, this Sanggunian has received an Indorsement from the Office of the City Mayor relative to the Memorandum of Agreement to be entered into by Land Bank of the Philippines (LBP) with the City Government of Ormoc and further requesting that the Honorable City Mayor be granted the authority to sign the said agreement for and in behalf of the City Government of Ormoc;

WHEREAS, said Memorandum of Agreement relates to the desire of the City Government of Ormoc to avail of Land Bank of the Philippines Radio Frequency Identification (RFID)-Enabled Card that combine the functions of a LANDBANK ATM Payroll/Regular ATM or Cash Card and as Employees ID;

WHEREAS, the LGU of Ormoc agree to shoulder the cost of production of RFID-enabled card for its employees and the corresponding equipment/s needed, subject to such terms and conditions mutually agreed upon;

WHEREAS, this august Body believes that the agreement is beneficial considering that it is for the convenience and more accessible financial transactions of the city officials & employees;

WHEREAS, the implementation of the MOA is further subject to the conditions therein set forth;
