A RESOLUTION APPROVING THE APPLICATION FOR PRELIMINARY APPROVAL AND LOCATIONAL CLEARANCE (PALC) AND DEVELOPMENT PERMIT (DP) PURSUANT TO ARTICLE IV SECTION 5 (C) OF E.O 648 AND PD 856 OF JARDIN DE LA PAZ MEMORIAL GARDEN, COMPRISING LOT 1608-B WITH AN AREA OF 64,091 SQ. METERS MORE OR LESS COVERED BY TRANSFER CERTIFICATE OF TITLE (TCT) NO. 17299 LOCATED AT BARANGAY SUMANGGA, ORMOC CITY CONTAINING EIGHTEEN THOUSAND AND EIGHTEEN (18,018) PLOTS.

WHEREAS, this Sanggunian has received a communication dated July 18, 2013 from Engr. Raoul E. Cam, City Planning & Development Coordinator, this City, forwarding the application for Preliminary Approval and Locational Clearance (PALC) and Development Permit, pursuant to Article IV Section 5 (C) of E.O 648 and PD 856 of Jardin De La Paz Memorial Garden located at Brgy Sumangga, Ormoc City;

WHEREAS, the proposed Memorial Garden project comprises Lot 1608-B with an area of 64,091 sq. meters more or less covered by Transfer Certificate of Title (TCT) No. 17299 containing Eighteen Thousand and Eighteen (18,018) plots;

WHEREAS, based on site inspection and evaluation of documents submitted, the City Planning and Development Office finds that said Memorial Project is proximate to the existing city cemetery and compatible with the existing land use of the area as well as suitable of said use;
