RESOLUTION NO. 2013-034

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A CONTRACT OF LEASE (RENEWAL) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC AS LESSOR WITH THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) REPRESENTED BY ITS SENIOR VICE PRESIDENT, VISMIN GROUP, ATTY. DIONISIO C. EBDANE AS LESSEE.

WHEREAS, this Sanggunian has received an Indorsement dated August 13, 2013 from the Office of the City Mayor relative to the communication of SOL A. ORCULLO, Branch Manager, Government Service Insurance System (GSIS), Tacloban Branch, dated July 25, 2013, conveying the intent of GSIS to renew the Contract of Lease of the space presently occupied by GSIS Satellite/Extension Office at the Ground Floor of Ormoc City Superdome;

WHEREAS, in view of the expiration of the previous agreement as approved per SP. Res. No. 2007-137 dated December 27, 2007 and considering that GSIS Ormoc Satellite Office still desires to continue occupying the subject premises to conduct operations as extension office pursuant to its charter, there is a need to renew the agreement concerning the matter;

WHEREAS, said Contract of Lease is for a period of Two (2) years and Five (5) months, commencing on August 01, 2013 and will end on December 31, 2015, and may be renewed upon mutual behest of both parties;

WHEREAS, this august Body finds the provisions of the Contract to be in order and its implementation is subject to the terms and conditions set forth therein;


ADOPTED, August 29, 2013.
