RESOLUTION NO. 2013-035

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BY AND AMONG THE LOCAL GOVERNMENT ACADEMY/INTERNATIONAL FINANCE CORPORATION, THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), AND THE CITY GOVERNMENT OF ORMOC FOR THE IMPLEMENTATION OF REGULATORY SIMPLIFICATION PROJECT (RSP)- ENHANCED BUSINESS PERMITS AND LICENSING SYSTEM (BPLS).

WHEREAS, this Sanggunian has received an Indorsement dated August 19, 2013 from the Office of the City Mayor in connection with the MOA by and among the Local Government Academy/International Finance Corporation, the Department of the Interior and Local Government (DILG), the City Government of Ormoc for the Implementation of Regulatory Simplification Project (RSP) - Enhanced Business Permits and Licensing System (BPLS) and further requesting that the Honorable City Mayor be granted the authority to sign the said agreement for and in behalf of the City Government of Ormoc;

WHEREAS, the RSP-EBPLS is designed to introduce reforms that would enhance the competitiveness of LGUs, encourage the formalization of business and more investment by further enhancing the streamlining of business registration procedures and to further reduce the number of steps, time and cost of business registration at the local level;

WHEREAS, the Local Government Academy, together with the International Finance Corporation-World Bank undertakes to provide the necessary and essential consultancy services through the provision of consultants and experts for the success of the Project, while the DILG Region 8, with the support of the City, will implement and develop the project deliverables as provided in the agreement;

WHEREAS, the Agreement stipulates the specific obligations of the concerned parties towards the achievement of the project implementation, under the terms and conditions set forth therein;

WHEREAS, this august Body finds the provisions of the MOA to be in order and beneficial to the city, hence, should be accorded affirmative action;

WHEREFORE, on motion of the City Councilor Benjamin S. Pongos, Jr. Committee on Laws & Ordinances, jointly seconded by City Councilors Mario M. Rodriguez and Rolando M. Villasencio; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. 
ADOPTED, August 29, 2013.
