A RESOLUTION DECLARING THAT RESOLUTION NO. 11, SERIES OF 2013 OF THE BARANGAY COUNCIL OF BARANGAY QUEZON JR., THIS CITY UNDER REVIEW HAS BEEN FOUND TO BE NOT IN CONFORMITY WITH R.A. 9003 ENTITLED: "ECOLOGICAL SOLID WASTE MANAGEMENT ACT OF 2000".

WHEREAS, the 13th Sangguniang Panlungsod ng Ormoc has received a Barangay Resolution No. 11, Series of 2013 of the Barangay Council of Barangay Quezon Jr., entitled: "A RESOLUTION ADOPTING THE CITY ORDINANCE ON REPUBLIC ACT 9003 FOR ECOLOGICAL SOLID WASTE MANAGEMENT OF REQUIRING ALL THE HOUSEHOLDS WITHIN THE BARANGAY TO SEGRIGATE AT SOURCE OF ALL KINDS OF HOUSEHOLD WASTE AND TO ESTABLISH COMPOST PIT FOR THE COMPOSTABLE, CONTAINER OR SACK FOR RECYCLABLE AND SEPARATE CONTAINER OR SACK FOR RESIDUAL WASTES";

WHEREAS, the aforementioned Barangay Resolution was submitted to this Sanggunian for review as amended in Section 57 of the Local Government Code of 1991;

WHEREAS, it is the observation of this august body that certain provisions of the subject barangay ordinance are inconsistent with existing laws and ordinances hence, needs to be modified and amended in accordance with the recommendations contained in the Committee Report of the Committee on Laws and Ordinances attached hereto and marked as Annex "A" of this resolution;


