*A RESOLUTION DECLARING THAT RESOLUTION NO. 16, SERIES OF 2013 OF THE BARANGAY COUNCIL OF BARANGAY QUEZON JR., THIS CITY UNDER REVIEW HAS BEEN FOUND TO BE NOT IN CONFORMITY WITH R.A. 9482 ENTITLED: "ANTI-RABIES ACT OF 2007" AN ACT PROVIDING FOR THE CONTROL AND ELIMINATION OF HUMAN AND ANIMAL RABIES, PRESCRIBING PENALTIES FOR VIOLATION THEREOF AND APPROPRIATING FUNDS THEREFOR.*

WHEREAS, the 13th Sangguniang Panlungsod ng Ormoc has received a Barangay Resolution No. 16, Series of 2013 of the Barangay Council of Barangay Quezon Jr., entitled: "A RESOLUTION ADOPTING THE CITY ORDINANCE ON ANTI-RABIES ACT ON REQUIRING ALL HOUSEHOLD WITHIN THE BARANGAY TO KEEP THEIR PET DOGS FROM STRAYING TO STREETS AND PUBLIC PLAZAS AND ANY OTHER PLACES OUTSIDE THEIR RESIDENCY WITHIN THE BARANGAY BY TYING OR KEEPING THEM INSIDE A CAGE;

WHEREAS, the aforementioned Barangay Resolution was submitted to this Sanggunian for review as amended in Section 57 of the Local Government Code of 1991;

WHEREAS, it is the observation of this august body that certain provisions of the subject barangay ordinance are inconsistent with existing laws and ordinances hence, needs to be modified and amended in accordance with the recommendations contained in the committee Report of the Committee on Laws and Ordinances attached hereto and marked as Annex "A" of this resolution;

WHEREFORE, foregoing premises considered, on motion of City Councilor Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, jointly seconded by City Councilors Corinne M. Corro and Marina T. Placido; be it




