WHEREAS, the 13th Sangguniang Panlungsod ng Ormoc has received a Barangay Resolution No. 17, Series of 2013 of the Barangay Council of Barangay Quezon Jr, entitled: " A RESOLUTION ADOPTING THE CITY ORDINANCE ON REPUBLIC ACT 9003 FOR ECOLOGICAL SOLID WASTE MANAGEMENT ON REQUIRING ALL HOUSEHOLDS WITHIN THE BARANGAY TO CONSTRUCT THEIR OWN SANITARY TOILET FOR THEIR PERSONAL USE;


