WHEREAS, this Sanggunian has received a communication dated July 31, 2013 from the Honorable City Mayor Edward C. Codilla requesting for the passage of a resolution designating one (1) of the 13th Sangguniang Panlungsod Members to take part as member of the People's Law Enforcement Board (PLEB);

WHEREAS, there is a need to reconstitute existing local special bodies and/or councils for the new term office of our newly-elected officials;

WHEREAS, the People's Law Enforcement Board is one of the special bodies of LGU-Ormoc which was created through SP Resolution No.39 dated 13 August 1992 pursuant to Republic Act. 6975, particularly Section 43 par. (a) Thereof;

WHEREAS, Section 43, par. (b) (1) of RA 6975, provides for the Composition of the PLEB as follows:

1. any member of the Sangguniang Panlungsod/Bayan chosen by his respective sanggunian;


