RESOLUTION NO. 2013-043

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), FOR THE IMPLEMENTATION OF THE PROJECT - REHABILITATION AND IMPROVEMENT OF EBONY STREET TO BE FUNDED BY THE SPECIAL LOCAL ROAD FUND (SLRF) UNDER R. A. 8794 OR THE MOTOR VEHICLE USERS CHARGE (MVUC) LAW THEREBY AMENDING SP RESOLUTION NO. 2013-103 DATED JUNE 20, 2013.

WHEREAS, an Urgent Indorsement dated August 22, 2013 from the Office of the City Mayor Edward C. Codilla, was received by this Sanggunian regarding the Memorandum of Agreement to be made and entered into by and between the Department of Public Works and Highways (DPWH) and the Local Government Unit of Ormoc City, for the implementation of an LGU project to be funded by the Special Local Road Fund (SLRF) under R.A 8794 or MVUC Law and further requesting that the Honorable City Mayor be granted the authority to sign the said agreement for and in behalf of the City Government of Ormoc;

WHEREAS, this agreement covers the release, utilization and liquidation of funds anent the implementation of a specific LGU project-"Rehabilitation and Improvement of Ebony Street, Ormoc City - with an appropriation of TWO MILLION THREE HUNDRED EIGHTY TWO THOUSAND & TWENTY ONE PESOS (P2,382,021.00) to be funded under the MVUC Special Local Road Fund;

WHEREAS, it can be recalled that there was a previous MOA acted upon by the 12th Sangguniang Panlungsod ng Ormoc under SP Resolution No. 2013-103, dated June 20, 2013, covering the same project, however, it has not been implemented by the City Engineering Office due to time constraints;

WHEREAS, considering the new term of office of the Honorable City Mayor Edward C. Codilla, there is a need to change the signatory of the representative of the City Government of Ormoc to make it binding upon the parties hence, this new agreement;

WHEREAS, this august Body finds the provisions of the MOA to be in order and its implementation is subject to the terms and conditions therein set forth;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Pedro Godiardo P. Ebcas, Vice-Chairman, Committee on Infrastructure Development, jointly seconded by City Councilors Marina T. Placido and Corinne M. Corro; be it


ADOPTED, September 05, 2013.
