RESOLUTION NO. 2013-044

RESOLUTION AUTHORIZING THE CITY MAYOR, HON. CODILLA, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) THROUGH THE LOCAL GOVERNMENT ACADEMY (LGA) AND THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG), REGIONAL OFFICE VIII, ON BEHALF OF THE CITY GOVERNMENT OF ORMOC, WITH REGARD THE MILLENIUM DEVELOPMENT GOALS (MDG) FAMILY-BASED ACTIONS FOR CHILDREN AND THEIR ENVIRONS IN THE SLUM (FACES).

WHEREAS, in consonance with the United Nations Millennium Development Goals of 2015 the Government of the Philippines, through the Department of Interior and Local Government is implementing the project entitled Millennium Development Goals (MDG) Family-based Actions for Children and their Environs in the Slum (FACES);

WHEREAS, in 2007, the National Economic and Development Authority highlighted in a Millennium Development Goals Midterm Progress Report that the country needs to work harder on MDG targets concerning universal access to education, maternal mortality and access to reproductive health services;

WHEREAS, a deadline has been set for the achievement of the Millennium Development Goals;

WHEREAS, as the deadline for the achievement of the MDG goals draws closer, both the national and local governmental entities are gearing towards the achievement of the MDG goals through localized development programs;

WHEREAS, the MDG Localization Framework adopted by the Philippine Government and its partners are focused on the LGU's as the driving force in localizing national MDG targets in the provinces, cities and municipalities;

WHEREAS, localization experiences of prior MDG Roll Out Projects in Butuan City and Pasay City translated the MDGs into family targets;

WHEREAS, the FACES Project builds on MDG's into very personal targets focusing on the child, specifically, a child in the slums- as the most vulnerable;

WHEREAS, the Family-based Actions for Children and their Environs in the Slum (FACES) Project is a flagship program of the Department of Interior and Local Government (DILG) on poverty reduction;

WHEREAS, this august Body, is driving towards a participative governance in line with achieving the Millennium Development Goals;

WHEREAS, the Local Government Academy in partnership with the DILG has selected Ormoc City as part of the expansion of the MDG FACES Project 3rd National Roll Out;

WHEREFORE, on motion of City Councilor Vincent L. Rama, Chairman Committee on Social Welfare, Senior Citizens, Women and Family, jointly seconded by City Councilors Pedro Godiardo P. Ebcas and Corinne M. Corro; be it
