RESOLUTION NO. 2013-045

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE ENVIRONMENTAL MANAGEMENT BUREAU (EMB) REGIONAL OFFICE VIII, FOR THE INSTALLATION/CONSTRUCTION OF THE AMBIENT AIR QUALITY MONITORING STATION.

WHEREAS, this Sanggunian has received an Urgent Indorsement dated August 27, 2013 from the Office of the City Mayor regarding the Memorandum of Agreement to be entered into by the Environmental Management Bureau (EMB) Regional Office VIII, and the City Government of Ormoc for the installation/construction of the Ambient Air Quality Monitoring Station and further requesting that the Honorable City Mayor be granted the authority to sign the said agreement for and in behalf of the City Government of Ormoc;

WHEREAS, in consonance with the provisions of Republic Act No. 8749 otherwise known as "Clean Air Act of 1999", the Environmental Management Bureau (EMB) is primarily tasked for the provision, control and abatement of all kinds of air pollution in the entire country and as part of their mandate and authority they shall coordinate with the private sector, non-governmental and civic organization, the local Government Units and other government agencies and bureaus, with the dissemination of information added to air quality management in the entire country;

WHEREAS, the City of Ormoc is a suitable site for air quality monitoring being an Independent Component City hence, the proposed installation/construction of the Ambient air Quality Monitoring Station is deemed beneficial to the City;

WHEREAS, the Agreement stipulates the specific obligations of the concerned parties towards the achievement of the project implementation, under the terms and conditions set forth therein;

WHEREFORE, on motion of the City Councilor Vincent L. Rama, Chairman, Committee on Environment and Natural Resources, severally seconded by City Councilors Pedro Godiardo P. Ebcas, Marina T. Placido and Corinne M. Corro; be it




RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be submitted to this sanggunian for its information and files;
