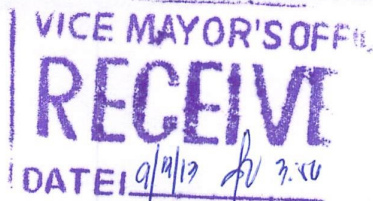

WHEREAS, the 13th Sangguniang Panlungsod ng Ormoc has received a Barangay Ordinance No. \_\_ of the Sangguniang Barangay of Barangay Alegria, Ormoc City, entitled: " AN ORDINANCE PRESCRIBING RENTAL FEES AND CHARGES FOR THE UTILIZATION OF BARANGAY ALEGRIA, ORMOC CITY";


