RESOLUTION NO. 2013-048

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE SERVICE LEVEL AGREEMENT (SLA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF HEALTH (DOH), CENTER FOR HEALTH DEVELOPMENT (CHD), EASTERN VISAYAS FOR THE IMPLEMENTATION OF "KALUSUGAN PANGKALAHATAN" THROUGH THE CITY-WIDE INVESTMENT PLANS FOR HEALTH (CIPH).

WHEREAS, this Sanggunian has received an Indorsement dated September 2, 2013 from the Office of the City Mayor relative to the Service Level Agreement to be entered into by the Department of Health, Center for Health Development, Eastern Visayas, with the City Government of Ormoc and further requesting that the Honorable City Mayor be granted the authority to sign the said agreement for and in behalf of the City Government of Ormoc;

WHEREAS, the Department of Health (DOH) has adopted the "Kalusugan Pangkalahatan" as the implementation framework for health sector reforms which seeks to improve, streamline, and scale up the reform strategies in Health Sector Reform Agenda (HSRA);

WHEREAS, "Kalusugan Pangkalahatan" is geared towards the achievement of better health outcomes, sustained health care financing and responsive health systems, especially for the poor, by pursuing the three (3) strategic thrusts of financial risk protection through expansion in NHIP enrollment and benefit delivery, especially for the poor, improved access to quality hospitals and health care facilities and attainment of the health-related Millennium Development Goals (MDGs), including non-communicable diseases;

WHEREAS, the National Government has mobilized resources for the implementation of health sector reforms through the City-wide Investment for Health in the cities, which include National Government contributions and grants from health development partners;

WHEREAS, the City of Ormoc has agreed to implement health sector reforms and has proven its capacity to utilize investment and sustain the reform process, among others;

WHEREAS, the Service Legal Agreement covers the management and implementation of the City's Annual Operational Plan (AOP) for 2013 to achieve a local health system performance consistent with internal and external benchmark of this SLA;

WHEREAS, the DOH-CHD and the Local Government of Ormoc mutually agreed that the Service Legal Agreement herein described shall cover activities from the period January to December 31, 2013;

WHEREAS, the Agreement stipulates the specific obligations of both parties towards the achievement of the project implementation, under the terms and conditions set forth therein;

WHEREFORE, on motion of the City Councilor Mario M. Rodriguez, Committee on Health and Sanitation, jointly seconded by City Councilors Rolando M. Villasencio and Corinne M. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE SERVICE LEVEL AGREEMENT (SLA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF HEALTH (DOH), CENTER FOR HEALTH DEVELOPMENT (CHD), EASTERN VISAYAS FOR THE IMPLEMENTATION OF "KALUSUGAN PANGKALAHATAN" THROUGH THE CITY-WIDE INVESTMENT PLANS FOR HEALTH (CIPH).


ADOPTED, September 12, 2013.
