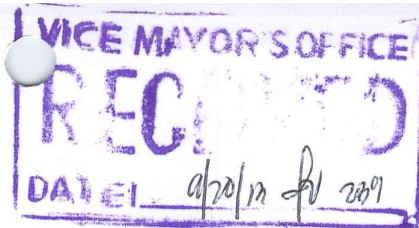

RESOLUTION NO. 2013-050

A RESOLUTION DECLARING THAT BARANGAY ORDINANCE NO. 02-2013 OF THE SANGGUNIANG BARANGAY OF BARANGAY LINAO, THIS CITY ENTITLED " AN ORDINANCE IMPOSING INCREASE IN MONTHLY RENTALS FOR THE BARANGAY GYMNASIUM STALLS (THIS INCREASE SHALL ONLY TAKE EFFECT UPON THE EXPIRATION OF THE LEASE CONTRACT) AND INCREASE ON CHARGES PER HOUR FOR THE USE OF BASKETBALL COURT AS ONE OF THE BARANGAY PROPERTIES OF BARANGAY LINAO, ORMOC CITY" UNDER REVIEW, HAS BEEN FOUND TO BE SUBSTANTIALLY IN CONFORMITY WITH EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, the 13th Sangguniang Panlungsod ng Ormoc has received a Barangay Ordinance No. 02-2013 of the Sangguniang Barangay of Barangay Linao,, Ormoc City, entitled: "AN ORDINANCE IMPOSING INCREASE IN MONTHLY RENTALS FOR THE BARANGAY GYMNASIUM STALLS (THIS INCREASE SHALL ONLY TAKE EFFECT UPON THE EXPIRATION OF THE LEASE CONTRACT) AND INCREASE ON CHARGES PER HOUR FOR THE USE OF BASKETBALL COURT AS ONE OF THE BARANGAY PROPERTIES OF BARANGAY LINAO, ORMOC CITY".

WHEREAS, the aforementioned Barangay Ordinance was submitted to this Sanggunian for review as mandated by Republic Act 7160, known as the "Local Government Code of 1991";


