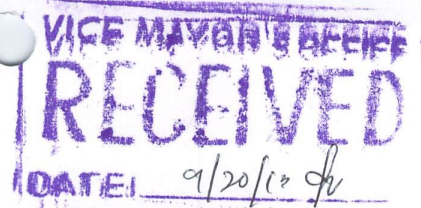

RESOLUTION NO. 2013-051

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
EDWARD C. CODILLA TO ENTER INTO AND SIGN THE
MEMORANDUM OF AGREEMENT (RENEWAL) FOR AND IN
BEHALF OF THE CITY GOVERNMENT OF ORMOC THROUGH
THE CITY HEALTH DEPARTMENT WITH SAN LORENZO RUIZ
COLLEGE OF ORMOC, INC.(SLRC) FOR THE AFFILIATION
OF ITS MEDICAL TECHNOLOGY INTERNS.

WHEREAS, this Sanggunian has received an Indorsement dated September 3, 2013 from the Office of the City Mayor regarding the renewal of the Memorandum of Agreement by and between the San Lorenzo Ruiz College of Ormoc, Inc.(SLRC) and the City Government of Ormoc and further requesting that the Honorable City Mayor be granted authority to sign the same for and on behalf of the City Government of Ormoc;

WHEREAS, the San Lorenzo Ruiz College of Ormoc, through a communication dated September 10, 2013, requests the renewal of the Memorandum of Agreement with the City Government of Ormoc, through the City Health Department, as a training Laboratory for SLRC Medical Technology Interns, in order to produce quality and competent medical technology professionals;

WHEREAS, the agreement stipulates that the parties shall make available the organized community health services at the San Pablo District Health Center for the necessary learning experience of the Medical Technology students of San Lorenzo Ruiz College of Ormoc, Inc. (SLRC), emphasizing the promotion of community, public and environmental health under the supervision of a licensed Medical Technologist who shall act as Clinical Instructor and will supervise and assist the students during their practicum at the said health center;

WHEREAS, it can be recalled that there was a previous MOA covering the matter, as embodied in SP Res. No. 2011-191 dated October 27, 2011, the duration of which is good for one (1) year only;

WHEREAS, in view of the coming expiration of the previous agreement, and considering that both parties still desire to continue their partnership, to be mutually beneficial to both the institution and the community, there is a need to renew the agreement concerning the matter;

WHEREAS, the said renewal of agreement covers a period of one (1) year from October 31, 2013 to November 01, 2014, and may be renewed upon mutual behest of both parties;

WHEREAS, this august Body finds the said Agreement to be in order;

WHEREFORE, on motion of City Councilor Mario M. Rodriguez, Chairman, Committee on Education, Culture & the Arts, duly seconded by Vincent L. Rama; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (RENEWAL) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC THROUGH THE CITY HEALTH DEPARTMENT WITH SAN LORENZO RUIZ COLLEGE OF ORMOC, INC.(SLRC) FOR THE AFFILIATION OF ITS MEDICAL TECHNOLOGY INTERNS;


ADOPTED, September 19, 2013.
