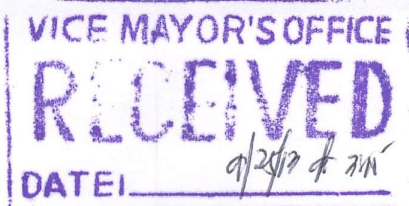

A RESOLUTION APPROVING THE APPLICATION FOR
ACCREDITATION FOR MEMBERSHIP IN THE LOCAL SPECIAL
BODIES AS PROVIDED FOR IN RULE XIII OF THE RULES
AND REGULATIONS IMPLEMENTING THE LOCAL
GOVERNMENT CODE OF 1991 OF ORMOC CITY CHAMBER OF
COMMERCE AND INDUSTRY, INCORPORATED.

WHEREAS, this Sanggunian has received the application of Ormoc City Chamber of Commerce & Industry, Inc. dated August 5, 2013, a legitimate non-government organization (NGO) representing the business sector/community in Ormoc City requesting for the re-activation of their accreditation/membership in the Local Special Bodies as provided for in Rule XIII of the Rules & Regulations Implementing the Local Government Code of 1991;

WHEREAS, DILG Memorandum Circular No. 2010-73 dated August 4, 2010 and 2013-70 dated July 24, 2013 calls for the accreditation of Civil Society Organizations, and Selection of Representatives to the Local Special Bodies of the Local Government Units;

WHEREAS, the Ormoc City Chamber of Commerce & Industry, Inc., with its goal to improve the business environment and investment climate in the City of Ormoc, would like to be a part in the development of Ormoc City for it to be seen and identified as among the most business-friendly local governments in the country through joint efforts of the local government and private sectors;

WHEREAS, this august body has reviewed said application including the other pertinent papers in support thereof, and has found out that all are in order, having complied the necessary requirements needed for accreditation in accordance with law;


