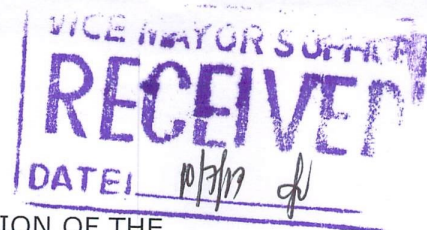

RESOLUTION NO. 2013-057

A RESOLUTION DECLARING THAT BARANGAY ORDINANCE  
NO. 05-2013 OF THE SANGGUNIANG BARANGAY OF  
BANTIGUE, THIS CITY, ENTITLED "IMPOSING CURFEW  
HOURS TO MINORS", UNDER REVIEW, HAS BEEN FOUND  
TO BE INVALID FOR BEING AN EXERCISE OF ULTRA VIRES  
POWERS BY THE SANGGUNIANG BARANGAY".

WHEREAS, the 13th Sangguniang Panlungsod ng Ormoc has received a  
Barangay Ordinance No .05-2013 of the Sangguniang Barangay of Bantigue,  
entitled: "IMPOSING CURFEW HOURS TO MINORS";

WHEREAS, the aforementioned Barangay Ordinance was submitted to this  
Sanggunian for review as mandated in Section 57 of Republic Act 7160, known as  
the "Local Government Code of 1991;

WHEREAS, it is the findings of this august body that the enactment of subject  
barangay ordinance is tantamount to an exercise of ultra vires powers by the  
Sangguniang Barangay, thus rendering subject barangay ordinance invalid, as  
contained and explained in the Committee Report of the Committee on Laws and  
Ordinances attached hereto and marked as Annex "A" of this resolution.;

Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, duly  
seconded by City Councilor Ruben R. Capahi; be it
