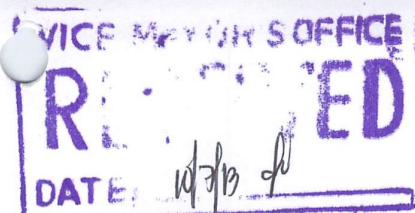
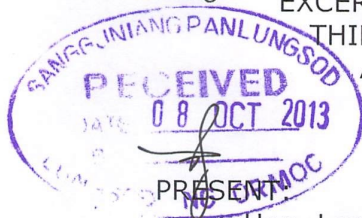

A RESOLUTION DECLARING THAT BARANGAY RESOLUTION
NO. 35-2013 OF THE SANGGUNIANG BARANGAY OF
BANTIGUE THIS CITY, ENTITLED, "A RESOLUTION FOR THE
ADOPTION AND TO REACTIVATE THE CITY ORDINANCE
KNOWN AND CITED AS THE 1995 CURFEW ORDINANCE FOR
MINORS", UNDER REVIEW, HAS BEEN FOUND TO BE
SUBSTANTIALLY IN CONFORMITY WITH EXISTING LAWS,
RULES AND REGULATIONS.

WHEREAS, the 13th Sangguniang Panlungsod ng Ormoc received a
Barangay Resolution No. 35-2013 of the Sangguniang Barangay of Bantigue, Ormoc
City, entitled: "A RESOLUTION FOR THE ADOPTION AND TO REACTIVATE THE CITY


