RESOLUTION NO. 2013-059

A RESOLUTION AMENDING SECTION 8, RULE VIII OF THE  
INTERNAL RULES OF PROCEDURE OF THE 13<sup>TH</sup>  
SANGGUNIANG PANLUNGSOD NG ORMOC.

WHEREAS, this august Body passed and approved SP Res. 2013-001 dated June 30, 2013, entitled: "A RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE 13TH SANGGUNIANG PANLUNGSOD NG ORMOC" in compliance with Section 50 of the Local Government Code of 1991 which provides that: "on the First Regular Session following the election of its members and within ninety (90) days thereafter, the Sanggunian concerned shall adopt and or update its existing rules of procedure";

WHEREAS, this Body also passed and approved SP. Res. 2013-10 dated July 11, 2013 amending certain provisions of the adopted internal rules of procedure of the 13<sup>th</sup> Sangguniang Panlungsod ng Ormoc;

WHEREAS, the said Resolution amended Section 8, Rule VIII of the Internal Rules of Procedure, setting the Pre-Session Caucus to be held every Friday at 9:00 o'clock in the morning;

WHEREAS, there is a necessity to further amend Section 8, Rule VIII of the internal rules of procedure to enable the members of this august Body to optimally utilize their time for effective and efficient public service;

WHEREAS, upon incorporation of the proposed amendment to the Internal Rules of Procedure of this Sangguniang, it shall now be read as follow:

RULE VIII – REGULAR AND SPECIAL SESSIONS  
AND PRE-SESSION CAUCUS

Res. No. 2013-059

Section 8. – The Pre-Session Caucus shall be held immediately after the adjournment of every Session. However, it may be held on Fridays, subject to the agreement of the members of the Sangguniang Panlungsod ng Ormoc.

WHEREFORE, upon motion of Hon. Benjamin S. Pongos, Jr., Chairman, Committee on Internal Rules of Procedure, jointly seconded by City Councilors Pedro Godiardo P. Ebcas and Tomas R. Serafica; be it


RESOLVE, AS IT IS HEREBY RESOLVED, to pass a resolution AMENDING SECTION 8, RULE VIII OF THE INTERNAL RULES OF PROCEDURE OF THE 13TH SANGGUNIANG PANGLUNGSOD NG ORMOC;
