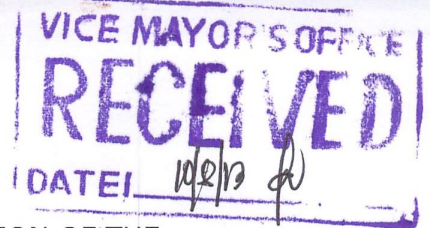
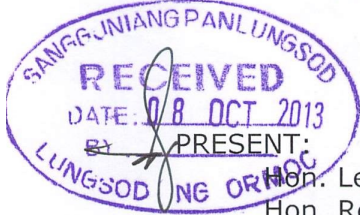

RESOLUTION NO. 2013-060

A RESOLUTION EXPRESSING PROFOUND SYMPATHIES AND

MAYOR NEPOMUCENO P. APARIS I, AND RECOGNIZING

WHEREAS, former Vice Mayor and incumbent City Councilor, Nepomuceno P. Aparis I, an acknowledged public servant and one of the respected political leaders in Ormoc City, passed away last September 30, 2013 at the age of only Sixty-Four (64);

WHEREAS, the late Nepomuceno P. Aparis I, was a practicing Lawyer by profession and a good educator who had served the City Government of Ormoc for twenty (20) long years, all with much sincerity and devotion. He first held his elective public office in 1987-1988 as OIC-City Councilor, and then 1988-1992 as Elected Vice Mayor; he was elected again as City Councilor from 1998 to 2004, and again as City Vice Mayor from 2004-2013. At the elections in May 2013, again he won as City Councilor, and garnered the No.1 spot, no less;

WHEREAS, during his lifetime, City Councilor Aparis' integrity and dedication to his work as a local government official made him the epitome of a true and dedicated public servant. His 20-year career in politics was unblemished and untarnished. He also exemplified transparency in the public service, no wonder he was bestowed with great respect by fellow Ormocanons;

WHEREAS, "Nep-nep" as he was fondly called, was an active member of various civic, religious, and professional organizations and he had been a man who inspired people from all walks of life. He left a precious legacy of love to his family, dedication and professionalism to his colleagues, kindness to his friends and relatives, and admiration and respect from his constituents;

WHEREAS, this august Body together with the City Officials and the people of Ormoc, grieves his passing and joins the entire City in prayer for the eternal repose of his soul, thankful always for his unselfish contributions to the betterment for the City Government of Ormoc and to her people as well;

WHEREAS, the Honorable Members of the 13th Sangguniang Panlungsod ng Ormoc, its City Officials and all Ormocanons, share the pain and sorrow of the family of the late Nepomuceno P. Aparis I: his wife Thelma O. Aparis, and children Christine Thelma, Eva Lynda, John Eulalio Nepomuceno, Lyneth Anne and Kareen Mae, as well as that of his brothers, sister and other relatives and wish to condole with them in this difficult time;


