A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. EDWARD C. CODILLA, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF ORMOC, WITH THE LAND BANK OF THE PHILIPPINES (LBP) RELATIVE TO THE GRANT OF LIVELIHOOD LOAN FACILITY TO QUALIFIED EMPLOYEES OF LGU-ORMOC.

WHEREAS, this Sanggunian received an Indorsement from the Office of the City Mayor relative to the Memorandum of Agreement (MOA) to be entered into by Land Bank of the Philippines (LBP) with the City Government of Ormoc and further requesting that the Honorable City Mayor be granted the authority to sign the said agreement for and in behalf of the City Government of Ormoc;

WHEREAS, said MOA relates to the desire of the City Government Employees to avail of the Livelihood Loan Facility from LBP;

WHEREAS, said loan facility will only be extended to qualified employees, subject to such terms and conditions as may be mutually agreed upon by the parties;

WHEREAS, this august body finds the provisions of the MOA to be in order and its implementation is subject to the terms and conditions set forth in the Agreement;


