RESOLUTION NO. 2013-063

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. EDWARD C. CODILLA, TO ENTER INTO AND SIGN THE CONTRACT OF CONSULTANCY OF ATTY. BEULAH COELI C. FIEL AS LEGISLATIVE CONSULTANT OF THE SANGGUNIANG PANLUNGSOD NG ORMOC AND ADMINISTRATIVE CONSULTANT OF THE OFFICE OF THE CITY VICE MAYOR EFFECTIVE JULY 1, 2013.

WHEREAS, the 13th Sangguniang Panlungsod ng Ormoc, as the legislative body of the city, desires to hire a CONSULTANT ON LEGISLATIVE AND ADMINISTRATIVE MATTERS who will assist the members of the Sangguniang Panlungsod ng Ormoc in setting the policy and direction, and provide technical assistance in the crafting of resolutions and ordinances, and such other matters pertinent to the legislative work of this Sanggunian, as well as assist the Vice Mayor and Presiding Officer in matters relating to the administrative concerns of said body;

WHEREAS, it is imperative that policy-making and legislative functions of the Sanggunian are satisfactorily addressed;

WHEREAS, this august Body, in line with the thrust in improving its legislative procedures for the betterment of public service, desires to engage the services of Atty. Beulah Coeli C. Fiel as consultant on legislative matters and other concerns or affairs of the Sangguniang Panlungsod, as well as a consultant on administrative matters in the Office of the City Vice Mayor;

WHEREAS, Atty. Fiel is a member of the Philippine Bar, having been admitted into the practice of law in 2005, and has extensive experience in litigation, administrative management and is conversant with the administration and governance of LGU's and Civil Service laws;

WHEREAS, Atty. Fiel's qualifications, with work experiences that include being a former Associate Solicitor at the Office of the Solicitor General, having helped put up and managed the Luneta Seafarers' Center in Manila, established the VinoyaFiel & Associates Law Offices in January 2008 and is still managing the same up to present, now renamed into B.C. Fiel & Associates Law Offices, co-founded and became the Secretary General of the Pro-active on Climate Change Leaders, was a former consultant of several local government units and other entities, and was the City Legal Officer of Tacloban City from July 2, 2012 to June 30, 2013, as well as attended the Introductory Course in Excellence in Local Legislation conducted by the National Center for Public Administration and Governance in University of the Philippines, Diliman Campus, make her the most qualified and most suitable Consultant on Legislative and in the Sangguniang Panglungsod ng Ormoc, and consultant on Administrative Matters in the Office of the City Vice Mayor;

WHEREAS, Atty. Fiel will serve as Legislative Consultant in the 13th Sangguniang Panlungsod and Administrative Consultant in the Office of the City Vice Mayor, effective 1 July until 31 December 2013, and shall perform functions which are not only highly technical, but more importantly, primarily confidential and policy determining, as provided in the Contract of Consultancy, a copy of which is hereto attached and made an integral part hereof, in accordance with the provisions of Republic Act No. 9184, otherwise known as the "Government Procurement Act;"

WHEREAS, Atty. Fiel, in her capacity as Legislative and Administrative Consultant, shall be entitled to a consultancy fee of THIRTY SEVEN THOUSAND PESOS (P37,000.00) per month;

WHEREAS, this august Body finds the provisions of the Consultancy Contract to be on order, hence, it is appropriate that the matter be accorded immediate action;

WHEREFORE, on motion Benjamin S. Pongos, Jr., Chairman, Committee on Good Government, jointly seconded by City Councilors Ruben R. Capahi and Vincent L. Rama; be it

RESOLVE, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE CITY MAYOR, HON. EDWARD C. CODILLA TO ENTER INTO AND SIGN THE CONTRACT OF CONSULTANCY OF ATTY. BEULAH COELI C. FIEL AS LEGISLATIVE CONSULTANT OF THE SANGGUNIAN PANLUNGSOD NG ORMOC AND ADMINISTRATIVE CONSULTANT OF THE OFFICE OF THE CITY VICE MAYOR EFFECTIVE JULY 1, 2013;


RESOLVED, FURTHER, that a copy of the final notarized Contract of Consultancy be submitted to this Sanggunian for its information and files;
