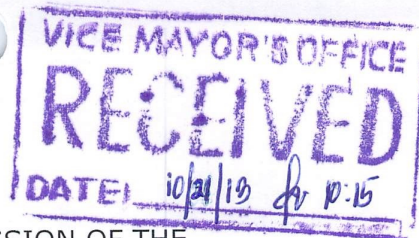

RESOLUTION NO. 2013-066

A RESOLUTION EXTENDING AUTHORITY TO THE ORMOC CITY SPORTS COUNCIL AS HOST AND ORGANIZER, IN BEHALF OF THE ORMOC CITY GOVERNMENT, OF THE PHILIPPINE COLLEGIATE CHAMPIONS LEAGUE (PCCL)-VISAYAS REGIONAL CHAMPIONSHIPS AND THE PHILIPPINE COLLEGIATE CHAMPIONS LEAGUE (PCCL)-SOUTHERN ISLANDS CHAMPIONSHIPS, AT THE ORMOC CITY SUPERDOME, TO SELL TICKETS FOR THE SAID EVENTS.

WHEREAS, it is one of the policy of the State, as embodied in the Constitution, to give priority to education, science and technology, arts, culture, and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development;

WHEREAS, the Local government of Ormoc City has ascended to such policy through sound sports programs and policies;

WHEREAS, Ormoc City Sports Council has been active in the organization and participation in local as well as regional sports endeavors;

WHEREAS, the Ormoc City Government, through the Ormoc City Sports Council will be hosting the "The Philippine Collegiate Champions League (PCCL)-Visayas Regional Championship and the Philippine Collegiate Champions League (PCCL)-Southern Islands Championship";

WHEREAS, the Philippine Collegiate Champions League (PCCL)-Visayas Regional Championship will be participated by champion Collegiate Teams from Ilo-ilo, Bacolod, Dumaguete, Bohol, Tacloban City and Ormoc City;

WHEREAS, the Philippine Collegiate Champions League (PCCL)-Southern Islands Championship will be participated by the Three (3) Top Teams from the CESAFI Cebu League, the Two (2) Champion Teams from the PCCL Mindanao League and the PCCL Visayas Regional Champion;

WHEREAS, the upcoming sports events will be accommodated by Ormoc City at the Ormoc City Superdome;

WHEREAS, the above said events will be held on November 15, 16, 17, 18, 19, 20, and 21, 2013;

WHEREAS, the ticket prices proposed by the Ormoc City Sports Council and approved by the Office of the City Mayor, through Hon. Edward C. Codilla, are as follows:

For the November 15, 16 and 17, 2013 play dates:

Php50.00	Courtside (Green Seats)
Php30.00	Upper Box (Yellow Seats)
Php10.00	General Admission

For the November 18, 19, 20, and 21, 2013 play dates:

Php70.00	Courtside (Green Seats)
Php50.00	Upper Box (Yellow Seats)
Php20.00	General Admission

WHEREAS, 100 pieces of patron tickets at Php500.00 each will likewise be sold to the public;

WHEREAS, the Ormoc City Sports Council, the Organizers of this occasion, will shoulder and pay all the expenses related to the event, including the 10% obligation to the Superdome;

WHEREAS, the remaining net balance will be turned over to the Ormoc City Treasury, after all the expenses will be paid;

WHEREFORE, on motion of City Councilor Vincent L. Rama, Chairman, Committee on Economic Enterprise, severally seconded by City Councilors Ruben R. Capahi, Pedro Godiardo P. Ebcas and Mario M. Rodriguez; be it
