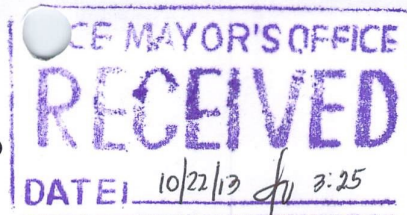

RESOLUTION NO. 2013-067

*A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
EDWARD C. CODILLA TO ENTER INTO AND SIGN A
CONTRACT OF POWER SUPPLY BY AND BETWEEN THE
LEYTE ELECTRIC COOPERATIVE INC. (LEYECO V) AND THE
CITY GOVERNMENT OF ORMOC.*

WHEREAS, an Indorsement dated September 30, 2013 from the Office of the City Mayor was received by the Sanggunian relative to the Contract of Power Supply to be entered into by City Government of Ormoc with Leyte V Electric Cooperative, Inc. (Leyeco V) and further requesting that the Honorable City Mayor be granted authority to sign the said Contract of Power Supply for and on behalf of the City of Ormoc;

WHEREAS, the contract provides that LEYECO V shall sell, and deliver all the electric power and energy needed at the city's BAGSAKAN CENTER located at Barangay Alegria, Ormoc City;

WHEREAS, the Acting City Legal Officer Atty. Marcelo O. Oñate, through an Indorsement dated September 30, 2013 recommended that the Contract of Power Supply, having found to be not contrary to law, public morals, public policy, public order or customs, be indorsed to the Sangguniang Panlungsod for approval and that the Honorable City Mayor be authorized to sign the same for and on behalf of City pursuant to Section 455 (b) (i) (vi) of RA 7160;

WHEREAS, this august Body conforms with the findings of the City Legal Officer;

WHEREFORE, on motion of City Councilor Pedro Godiardo P. Ebcas, Vice-Chairman, Committee on Energy Conservation, jointly seconded by City Councilors Rolando M. Villasencio and Tomas R. Serafica; be it

RESOLVE, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A CONTRACT OF POWER SUPPLY BY AND BETWEEN THE LEYTE ELECTRIC COOPERATIVE INC. (LEYECO V) AND THE CITY GOVERNMENT OF ORMOC;
