

RESOLUTION NO. 2013-073

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO UTILIZE THE AMOUNT OF ONE MILLION SIX **HUNDRED THOUSAND** (P1,600,000.00) TO BE TAKEN FROM OUT OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND - A NON OFFICE ACCOUNT OF THE CITY'S ANNUAL BUDGET FOR CY 2013, AS ASSISTANCE TO THE LGU'S DECLARED UNDER THE STATE OF CALAMITY DUE TO THE RECENT BOHOL EARTHQUAKE AS FOLLOWS: PROVINCE OF BOHOL, CITY OF TAGBILARAN, PROVINCE OF CEBU AND CITY OF CEBU.

WHEREAS, the Provinces of Bohol and Cebu, and the Cities of Tagbilaran and Cebu were seriously devastated by a 7.2 magnitude earthquake that occurred last October 15, 2013;

WHEREAS, the catastrophe resulted to many casualties and thousands of affected and displaced families, caused massive destruction to properties with an estimated 900M more or less worth of damages to roads, bridges and flood control projects;

WHEREAS, according to the National Disaster Risk Reduction and Management Council (NDRRMC), the earthquake was the deadliest to hit the Philippines in the past Twenty-Three (23) years having released equivalent to 32 Hiroshima bombs. Corollary to the tragedy, the affected areas were immediately placed under the "State of Calamity"

WHEREAS, the Local Disaster Risk Reduction and Management Office (LDRRMO) of Ormoc City, through a communication dated October 18, 2013 from Mr. Bienvenido A. Matiga, DRRMO Designate, has recommended to the Honorable City Mayor Edward C. Codilla for the LGU of Ormoc to extend financial assistance to the affected areas through their respective LGU's, as follows:

Province of Bohol - P 500,000.00
Province of Cebu - 500,000.00
City of Tagbilaran - 300,000.00
City of Cebu - 300,000.00
T O T A L - P1,600,000.00

WHEREAS, the Office of the City Mayor through an Indorsement dated October 21, 2013, has forwarded to this sanggunian the said recommendation from the LDRRMO and further requests that the matter be treated on an urgent basis;

WHEREAS, both the City Budget Officer and the City Treasurer have issued certifications that the sum of One Million Six Hundred Thousand Pesos (P1,600,000.00) is available from the Local Disaster Risk reduction and Management Fund, which amount may be utilized as cash assistance to the LGUs devastated by the earthquake last October 15, 2013;

WHEREAS, the LGU of Ormoc City, having gone through the same catastrophe during the November 5, 1991 flashflood, commiserate with the people in the affected places, as well as that of their respective LGUs which were among the first responders on the relief and rehabilitation operation during the Ormoc Flashflood;

WHEREAS, Section 1, Rule 18 of the Implementing Rules and Regulations of R.A. 10121 provides that "upon recommendation of the Local Disaster Risk Reduction Management Office (LDRRMO) and approval of the sanggunian concerned, the Local Disaster Risk Reduction Management Council (LDRRMC) may transfer the said fund to support disaster risk reduction work of other LDRRMOs which are declared under State of Calamity";

WHEREAS, Section 5(b) of the Rules and Regulations Implementing R.A. 8185 states that: "A portion of the Calamity Fund may also be authorized to be used by the Local Government Unit concerned to provide financial assistance to other Local Government Units whose area or portion thereof have been declared under state of calamity by its sanggunian";

WHEREFORE, on MASS MOTION of the Body; be it

RESOLVE, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO UTILIZE THE AMOUNT OF ONE MILLION SIX HUNDRED THOUSAND (P1,600,000.00) PESOS TO BE TAKEN FROM OUT OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND – A NON OFFICE ACCOUNT OF THE CITY'S ANNUAL BUDGET FOR CY 2013, AS ASSISTANCE TO THE LGU'S DECLARED UNDER THE STATE OF CALAMITY DUE TO THE RECENT BOHOL EARTHQUAKE AS FOLLOWS: PROVINCE OF BOHOL, CITY OF TAGBILARAN, PROVINCE OF CEBU AND CITY OF CEBU;
