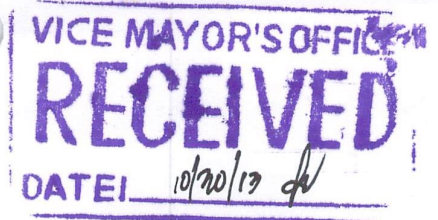

WHEREAS, on October 22, 2013 the Honorable City Mayor Edward C. Codilla has endorsed to this sanggunian for appropriate legislative action, the City Development Council (CDC) Resolution No. 1, Series of 2013, dated October 21, 2013 entitled: "A RESOLUTION APPROVING THE EXECUTIVE-LEGISLATIVE AGENDA (ELA)- CAPACITY DEVELOPMENT (CAPDEV) AGENDA 2014-2016 OF THE CITY OF ORMOC AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME";


