WHEREAS, Ormoc City was hit by Typhoon Yolanda on November 8, 2013 and suffered extensive damage;

WHEREAS, the City Disaster Risk Reduction and Management Council (C DRRMC) convened on November 9, 2013 and unanimously approved a "Resolution Declaring a State of Calamity in Ormoc City";

WHEREAS, the Sangguniang Panglungsod, meeting in an emergency or Special Session, has decided to confirm the CDRRMC Resolution placing Ormoc City under a State of Calamity and authorizing the City Mayor to utilize the Calamity Fund of the city;

NOW, THEREFORE, on motion of City Councilor Pedro Godiardo P. Ebcas, and seconded *en masse* by all the other City Councilors present; be it


