AN URGENT APPEAL TO THE NATIONAL GOVERNMENT, PRIVATE SECTOR AND OTHER CONCERNED  
INDIVIDUALS/ENTITIES FOR HELP AND ASSISTANCE FOR ORMOC CITY

WHEREAS, Ormoc City was hit by Typhoon Yolanda on November 8, 2013 and suffered extensive damage;

WHEREAS, the City Disaster Risk Reduction and Management Council (CDRRMC) convened on November 9, 2013 and unanimously approved a "Resolution Declaring a State of Calamity in Ormoc City";

WHEREAS, the Sangguniang Panlungsod, meeting in an Emergency or Special Session, has decided to confirm the CDRRMC Resolution placing Ormoc City under a State of Calamity and authorizing the City Mayor to utilize the Calamity Fund of the city;

WHEREAS, the people of Ormoc need help and assistance -- be it in the form of cash or in kind -- from the National Government and other concerned individuals/entities;

NOW, THEREFORE, on motion of City Councilor Pedro Godiardo P. Ebcas, and seconded *en masse* by all the other City Councilors present; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a "AN URGENT APPEAL TO THE NATIONAL GOVERNMENT, PRIVATE SECTOR AND OTHER CONCERNED INDIVIDUALS/ENTITIES FOR HELP AND ASSISTANCE FOR ORMOC CITY;"


