RESOLUTION NO. 2013-079

A RESOLUTION URGING THE BUSINESS COMMUNITY THRU THE ORMOC CHAMBER OF COMMERCE AND INDUSTRY AND THE ORMOC CHINESE CHAMBER OF COMMERCE TO ASSIST AND PARTNER WITH THE LGU ORMOC IN MONITORING AND ENSURING THE STABILIZATION OF PRICES OF BASIC NECESSITIES AND PRIME COMMODITIES, AND IN PROTECTING THE CONSUMERS AGAINST UNDUE PRICE INCREASES DURING THE STATE OF CALAMITY BROUGHT ABOUT BY SUPER TYPHOON "YOLANDA".

WHEREAS, Ormoc City was badly hit by super typhoon "Yolanda" on November 8, 2013 resulting to loss of lives, considerable injury to persons and tremendous property damage to the city and other cities and municipalities;

WHEREAS, the 13th Sangguniang Panlungsod in an emergency meeting or special session, passed and approved Resolution No. 2013-077, dated November 9, 2013, entitled: "A RESOLUTION CONFIRMING THE DECLARATION OF A STATE OF CALAMITY IN ORMOC CITY";

WHEREAS, Section 2, of Republic Act No. 7581, otherwise known as the "Price Act", stipulates that it is also a declared policy of the state to provide effective and sufficient protection to consumers against hoarding, profiteering and cartels with respect to the supply, distribution, marketing and pricing of said goods, especially during periods of calamity, emergency, widespread illegal price manipulation and other similar situations;

WHEREAS, in order to protect the consumers from undue and unreasonable escalation of prices of basic necessities and prime commodities that may occur on occasion of said calamity, there comes an extreme urgency to stabilize the prices of the same and the LGU Ormoc is now earnestly seeking the assistance and support of the business community thru the Ormoc Chamber of Commerce and Industry, and the Ormoc Chinese Chamber of Commerce to achieve said end;

WHEREFORE, on motion of City Councilor Benjamin S. Pongos Jr., Chairman, Committee on Trade, Commerce and Industry, duly seconded en masse by all other City Councilors present; be it
