WHEREAS, Ormoc City was badly hit by typhoon "Yolanda" on November 8, 2013 causing great
damages to lives and properties in the city and neighboring cities and municipalities;

WHEREAS, the 13th Sangguniang Panlungsod had an emergency meeting or special session and
passed and approved Resolution No. 2013-077, dated November 9, 2013, entitled: "A RESOLUTION
CONFIRMING THE DECLARATION OF A STATE OF CALAMITY IN ORMOC CITY";

WHEREAS, there are now pledges and cash donations from private individuals/entities who
want to help Ormoc City;

WHEREAS, there is a need to open accounts in private banks to make it easier for private
donors to deposit their cash donations;

WHEREFORE, on motion of City Councilor Ruben R. Capahi, duly seconded en masse by all the
other City Councilors present; be it

RESOLVE, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING THE CITY MAYOR,
THE CITY TREASURER AND/OR THE CITY ACCOUNTANT TO OPEN ACCOUNTS WITH PRIVATE BANKS TO
FACILITATE THE DEPOSIT OF CASH DONATIONS FOR ORMOC CITY;


