RESOLUTION NO. 201

A RESOLUTION REQUESTING THE HONORABLE EDWARD C. CODILLA, CITY MAYOR OF ORMOC, TO FACILITATE THE SUSPENSION OF COLLECTION OF MONTHLY AMORTIZATIONS MADE THRU **AUTOMATIC** SALARY DEDUCTIONS UPON APPLICATION BY CONCERNED ORMOC CITY GOVERNMENT EMPLOYEES REGARDING THEIR LOANS CONTRACTED WITH THE LANDBANK OF THE PHILIPPINES (LBP) ORMOC BRANCH AND DEVELOPMENT BANK OF THE PHILIPPINES (DBP) ORMOC BRANCH FOR A PERIOD OF AT LEAST SIX (6) MONTHS STARTING DECEMBER THIS YEAR AS A FORM OF ASSISTANCE TO LOSSES INCURRED DUE TO SUPER TYPHOON YOLANDA.

WHEREAS, this august Body received Board Resolution No. 11-01 of the City of Ormoc Government Employees Association (COGEA) dated November 18, 2013 and entitled "A RESOLUTION REQUESTING THE HON. EDWARD C. CODILLA, CITY MAYOR OF ORMOC, TO FACILITATE THE SUSPENSION OF THE COLLECTION AND/OR DEDUCTION FROM THE SALARY OF ALL EMPLOYEE IN THE CITY GOVERNMENT OF ORMOC ON THEIR MONTHLY AMORTIZATION/PAYMENT OF LOANS OTHERWISE KNOWN AS MORATORIUM, CONTRACTED WITH THE LANDBANK OF THE PHILIPPINES AND DEVELOPMENT BANK OF THE PHILIPPINES, BOTH SITUATED IN ORMOC CITY, FOR A PERIOD OF SIX (6) MONTHS STARTING DECEMBER OF THIS YEAR."

WHEREAS, the said board resolution was passed in view of the urgency to assist Ormoc City government employees in the rebuilding, repairing and recovering from the considerable damage and losses sustained from the immense devastation and destruction wrought by super typhoon Yolanda to their homes, businesses, and other belongings, not to mention, personal harm, injury and loss of lives that some may have suffered on that fateful morning of November 8, 2013;

WHEREAS, in view of the catastrophic and destructive effects of super typhoon Yolanda on the lives and properties of Ormocanons, it becomes imperative for the national government to extend whatever assistance it can not only to assist Yolanda survivors in their losses and damage but also to aid them in rising from the ruins and destruction by repairing their broken homes and lives at the soonest time possible, as was nobly exemplified by the Government Service Insurance System (GSIS) thru a six-month loan moratorium immediately extended after the super typhoon to Yolanda-hit members and pensioners starting November 2013 to April 2014, whereby payment for existing loans of affected members will only resume in May of 2014, a copy of the document announcing said moratorium is hereby attached to this resolution;

WHEREAS, for this purpose a suspension of payments of their monthly loan amortizations with the LBP and DBP, Ormoc City branches, for a period of at least six (6) months starting December of this year, upon application or request with said banks by the concerned Ormoc City government employee, will certainly hugely alleviate his plight, allow him to repair damages sustained, and therefore uplift his dampened spirit;

WHEREAS, it is indeed this august Body's most earnest and humble opinion and sentiment, at the risk of sounding repetitive as this cannot be overemphasized enough, that the request contained in the mentioned COGEA board resolution is quite justified and most worthy of the Body's full support and more importantly, the affirmative consideration or action of the two concerned government-owned banks in view not only of the mentioned massive destructive effects of the strongest recorded super typhoon to ever hit the Philippines, if not arguably the entire world, but also in consideration of the fact that past bank loan records indubitably attest that generally Ormoc City government employees loan borrowers have shown to be diligent and faithful payers, and quite frankly would never consider of making this sincere plea if not for the enormously dire predicaments they are in, thus faultlessly constraining them to most earnestly seek herein assistance from the LBP and DBP;

WHEREFORE, foregoing premises considered, on motion of City Councilor Benjamin S. Pongos, Ir., Chairman, Committee on Laws and Ordinances, jointly seconded by City Councilors Corinne M. Corro and Tomas R. Serafica; be it

RESOLVE, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION REQUESTING THE HONORABLE EDWARD C.
