

RESOLUTION NO. 2013-085

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
EDWARD C. CODILLA TO ENTER INTO AND SIGN A
MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF
OF THE CITY GOVERNMENT OF ORMOC WITH THE ENERGY
DEVELOPMENT CORPORATION (EDC) FOR THE CONCRETING
OF THE 1.325 KILOMETER BRGY. MILAGRO TO BRGY. LAKE
DANAO ROAD.

WHEREAS, this Sanggunian received an Indorsement dated October 30, 2013 from the Office of the City Mayor regarding the Memorandum of Agreement to be made and entered into by the Energy Development Corporation (EDC) and the City Government of Ormoc and further requesting that the Honorable City Mayor be granted the authority to sign the said agreement for and in behalf of the City Government of Ormoc;

WHEREAS, City Government of Ormoc sought the assistance of Energy Development Corporation (EDC) for the concreting of the 1.325 kilometer Brgy. Milagro to Brgy. Lake Danao Road;

WHEREAS, Energy Development Corporation (EDC) recognized the operational benefit of said project in Leyte since it is an alternative access route to its Mahanagdong A and B Power Plants, Steam Fields and the Fluid Collection and Reinjection System. Furthermore, EDC undertakes a Corporate Social Responsibility (CSR) in its project sites as its commitment to the advancement of community wealth and welfare;

WHEREAS, the City recognizes as well the need, urgency and operational benefits of the "PROJECT", since it will greatly improve the comfort and safety of the residents, guests and tourists' accessibility for its tourism pride, the famous Lake Danao and for the benefit of the residents in the area, to preclude accidents which may be brought about by the existing road's bad conditions;

WHEREAS, the EDC has agreed to provide the requested assistance to the City which hosts some of EDC's Leyte Geothermal Power Plants, for the concreting of the 1.325 Kilometer Brgy. Milagro to Brgy. Lake Danao Road (the "PROJECT") as part of their CSR Program;

WHEREAS, the Agreement stipulates the specific obligations of the concerned parties towards the achievement of the project implementation, under the terms and conditions set forth therein;

WHEREFORE, on motion of City Councilor Rolando M. Villasencio, Chairman, Committee on Infrastructure, jointly seconded by City Councilors Tomas R. Serafica and Pedro Godiardo P. Ebcas; be it

RESOLVE, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE ENERGY DEVELOPMENT CORPORATION (EDC) FOR THE CONCRETING OF THE 1.325 KILOMETER BRGY. MILAGRO TO BRGY. LAKE DANAOS ROAD;


ADOPTED, November 28, 2013.
