RESOLUTION NO. 2013-090

*A RESOLUTION CONCURRING WITH THE  
APPOINTMENT BY THE HONORABLE ORMOC CITY MAYOR  
EDWARD C. CODILLA OF ATTY. FRANCIS A. PEPITO TO THE  
POSITION OF CITY GOVERNMENT DEPARTMENT HEAD I  
(CITY ADMINISTRATOR), THIS CITY, EFFECTIVE  
NOVEMBER 7, 2013.*

WHEREAS, the Thirteenth (13<sup>th</sup>) Sangguniang Panlungsod ng Ormoc received an indorsement dated November 27, 2013 from the Honorable City Mayor Edward C. Codilla relative to the appointment of Atty. Francis A. Pepito as City Government Department Head I (City Administrator) of LGU Ormoc effective November 7, 2013.

WHEREAS, the position of City Administrator has been left vacant following the expiration of the appointment of Mr. Manuel M. Pascual last June 2013.

WHEREAS, Section 454 Paragraph (d) of RA 7160, otherwise known as the Local Government Code of 1991, provides that:

"Unless otherwise provided herein, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the majority of all sanggunian members, subject to civil service law, rules and regulations. The Sangguniang Panlungsod shall act on the appointment within Fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed."

WHEREAS, Atty. Pepito is a lawyer who was admitted into the Philippine bar in September 2000, worked as Associate Lawyer of Hontanasas Law Office from May 2001 to June 2003, became a Partner of Pepito & Pepito Law Office from June 2003 to January 2007, and served as Managing Partner of Pepito Canete Law Firm from January 2007 to November 7, 2013, whereby, he gained sufficient experience in managing the said firms' operations and supervising its respective organizations;

WHEREAS, upon close evaluation and examination by the Committee on Good Government of this Sanggunian of Atty. Pepito's qualifications and fitness to hold the public office relative to subject appointment, it was its findings that he possessed all the qualifications and none of the disqualifications provided by law, that he is substantially equipped with the necessary skills and demeanor required in order to fittingly carry out the important position of CITY ADMINISTRATOR of LGU Ormoc, and that his subject appointment is accordance with the standards prescribed by the Civil Service Commission:

WHEREFORE, on motion of City Councilor Benjamin S. Pongos, Jr, Chairman, Committee on Good Government, severally seconded by City Councilors Pedro Godiardo P. Ebcas, Tomas R. Serafica, Antonio M. Codilla, Marina T. Placido and Vincent L. Rama; be it,

RESOLVE, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION CONCURRING WITH THE APPOINTMENT BY THE HONORABLE ORMOC CITY MAYOR EDWARD C. CODILLA OF ATTY. FRANCIS A. PEPITO TO THE POSITION OF CITY GOVERNMENT DEPARTMENT HEAD I (CITY ADMINISTRATOR, THIS CITY, EFFECTIVE NOVEMBER 7, 2013;


