RESOLUTION NO. 2013-094

A RESOLUTION AUTHORIZING THE HONORABLE CITY
MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A
MEMORANDUM OF UNDERSTANDING (MOU) FOR AND IN
BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE
UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP),
REPRESENTED BY YURI AFANASIEV, SENIOR RECOVERY
COORDINATOR, FOR THE PURPOSE OF PROVIDING
FRAMEWORK FOR THE IMPLEMENTATION OF UNDP
PHILIPPINES' TYPHOON YOLANDA EARLY RECOVERY
PROGRAMME.

WHEREAS, this Sanggunian received an Indorsement dated December 17, 2013 from the Office of the City Mayor regarding the Memorandum of Understanding to be entered into by the United Nations Development Programme represented by Yuri Afanasiev, Senior Recovery Coordinator and the City Government of Ormoc and further requesting that the Honorable City Mayor be granted authority to sign the said MOU for and in behalf of the City Government of Ormoc;

WHEREAS, UNDP is interested in ensuring the early recovery of communities affected by Super Typhoon Yolanda through support to governance capacities of selected LGUs in restoring basic social services, providing emergency employment and reestablishing disrupted livelihoods to promote sustainable development, eradication of poverty, advancement of women, good governance and the rule of law;

WHEREAS, the purpose of this MOU is to provide a framework of cooperation and facilitate collaboration between UNDP and the City of Ormoc, on a non-exclusive basis, in areas of common interest such as emergency employment/debris-clearing, livelihood recovery restoration, good governance, and disaster risk reduction;

WHEREAS, both parties share similar disaster response and recovery missions and wish to cooperate in those areas of mutual concern to enhance the effectiveness of their efforts to address the needs of typhoon-affected communities;

WHEREAS, the implementation of the MOU is subject to the terms and conditions set forth therein;

WHEREFORE, on motion of City Councilor Pedro Godiardo P. Ebcas, Chairman, Committee on Public Safety, severally seconded by City Councilors Vincent L. Rama, Mario M. Rodriguez, Ruben R. Capahi and Antonio M. Codilla; be it

RESOLVE, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP), REPRESENTED BY YURI AFANASIEV, SENIOR RECOVERY COORDINATOR, FOR THE PURPOSE OF PROVIDING FRAMEWORK FOR THE IMPLEMENTATION OF UNDP PHILIPPINES' TYPHOON YOLANDA EARLY RECOVERY PROGRAMME;


ADOPTED, December 23, 2013.
