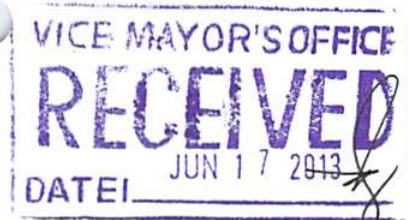

**RESOLUTION NO. 2013-099**

**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO GRANT ADDITIONAL HONORARIA TO THE CITY BOARD OF CANVASSERS (CBOC) AND COMELEC SUPPORT STAFF, IN THE TOTAL AMOUNT OF THIRTY EIGHT THOUSAND PESOS (P38,000.00), CHARGEABLE AGAINST THE 2013 ELECTION EXPENSE ACCOUNT OF THE CITY TREASURER'S OFFICE.**

WHEREAS, this Sanggunian received a communication dated May 29, 2013 from the Office of the City Mayor urgently requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to grant additional honoraria to the City Board of Canvassers (CBOC) and COMELEC Support Staff, in the total amount of THIRTY EIGHT THOUSAND PESOS (P38,000.00), chargeable against the 2013 election expense account of the City Treasurer's Office;

WHEREAS, the Commission on Elections through a letter dated May 28, 2013 requested the Ormoc City LGU for an additional honoraria for the Members of the City Board of Canvassers including the Consolidated Canvassing System (CCS) Operator and their support staff;

WHEREAS, pursuant to COMELEC Minute Resolution No. 07-0626, the CBOC members and CCS Operator are entitled to a minimum rate, subject to the availability of funds and discretion of the LGU authority, aside from the honorarium given by the Commission;

WHEREAS, this august body believes that said request is reasonable, hence, the same should be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Rafael C. Omega Jr., Chairman, Committee on Finance and Appropriations, jointly seconded by City Councilors Sotero M. Pepito and Corinne M. Corro; be it


