Codilla requesting for the passage of a resolution authorizing His Honor to enter into and sign a Memorandum of Agreement (MOA) for and in behalf of the City Government of Ormoc with the Department of Public Works and Highways (DPWH) for the implementation of the Special Local Road Fund (SLRF) under R. A. 8794 or the Motor Vehicle Users Charge (MVUC) Law;

WHEREAS, this agreement covers the release, utilization and liquidation of funds for the LGU eligible projects and activities such as road maintenance, road safety devices and traffic management funded by the Special Local Road fund to be implemented by LGUs in accordance with the policies, standards and procedures of R. A. 8794 (MVUC Law) and its Implementing Rules & Regulations (IRR);

WHEREAS, the agreement further specifies the implementation of SLRF Projects along City Roads in the City of Ormoc particularly the Rehabilitation and Improvement along Ebony St., Ormoc City, with an appropriation of TWO MILLION THREE HUNDRED EIGHTY TWO THOUSAND & TWENTY ONE PESOS (P2,382.021.00) under the MVUC Special Local Road Fund;
