RESOLUTION NO. 2013-021

RESOLUTION REQUESTING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO FILL-UP THE THREE (3) VACANT POSITIONS CREATED FOR THE CITY DISASTER RISK REDUCTION MANAGEMENT OFFICE.

WHEREAS, Section 12 of Republic Act 10121 provides that Local Disaster Risk Reduction & Management Office (LDRRMO) shall be under the Office of the Governor, City or Municipal Mayor, and the Punong Barangay in case of the BDRRMC and shall be initially organized and composed of a Disaster Risk Reduction & Management Officer to be assisted by three (3) staff responsible for: (1) administration and training, (2) research and planning, and (3) operations and warning;

WHEREAS, in consonance with the provisions of RA, 10121, the Twelfth Sangguniang Panlungsod has enacted Ordinance No. 176, dated October 31, 2012, entitled: "AN ORDINANCE ESTABLISHING A CITY DISASTER RISK REDUCTION MANAGEMENT OFFICE (CDRRMO) UNDER THE OFFICE OF THE CITY MAYOR IN ACCORDANCE TO SECTION 12 OF RA 10121 AND ITS IMPLEMENTING RULES AND REGULATIONS";

WHEREAS, Section 4 of Ordinance No. 176 provides for the creation of three (3) key positions for the CDRRMO, namely, One (1) Civil Defense Officer II, SG-15, One (1) Civil Defense Officer I. SG-11, & One (1) Administrative Aide I, SG-1. The position titles were attuned to the inherent functions and duties of the office;

WHEREAS, the necessary funds for the new positions created was duly provided in Appropriation Ordinance No. 2013-005 dated March 25, 2013;

WHEREAS, it is imperative that the initial personnel complement of CDRRMO, comprising of the aforementioned three (3) positions be filled-up in order to formalize the organizational structure of the office and carry out the purpose of which Ordinance No. 176 was enacted;

WHEREAS, this request for the Honorable City Mayor to fill-up the said positions is for the effective and efficient functioning of the CDRRMO amid the emerging challenges brought by disasters of the present times;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Pedro Godiardo P. Ebcas, Chairman, Committee on Public Safety, severally seconded by City Councilors Ruben R. Capahi, Rolando M. Villasencio and Vincent L. Rama; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION REQUESTING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO FILL-UP THE THREE (3) VACANT POSITIONS CREATED FOR THE CITY DISASTER RISK REDUCTION MANAGEMENT OFFICE.
