RESOLUTION NO. 2014-002

A RESOLUTION EARNESTLY REQUESTING THE GOVERNMENT
SERVICE INSURANCE SYSTEM (GSIS) AND THE
DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO
IMPLEMENT REP. ACT NO. 6942, ENTITLED: "AN ACT
INCREASING THE INSURANCE BENEFITS OF LOCAL
GOVERNMENT OFFICIALS AND PROVIDING FUNDS
THEREFOR".

WHEREAS, Rep. Act No. 6942, entitled: "AN ACT INCREASING THE
INSURANCE BENEFITS OF LOCAL GOVERNMENT OFFICIALS AND PROVIDING
FUNDS THEREFOR" entitles Barangay Officials during their incumbency insurance
coverage which shall include, but shall not be limited to temporary and permanent
disability, double indemnity, death and burial benefits which is likewise buttressed
by the provisions of the Local Government Code of 1991 (R.A.No. 7160) Section
393, par. (b), Item No. 2, thereof;

WHEREAS, the aforementioned law has not been implemented thereby
prejudicing and depriving the Barangay Officials of the benefits provided therein;

WHEREAS, Section 6 of Rep. Act. No. 6942, in part provides: "For all the
insurance benefits provided in the preceding sections, the national government of
the Republic of the Philippines shall appropriate annually and include in the General
Appropriations Act the total annual premiums based on the actual number of local
officials covered under Section One hereof and as certified by the Department of
Local Government. x x x The entire appropriation for the payment of the foregoing
total annual premiums shall be released to the Government Service Insurance
System during the first month of every calendar year. x x x."

WHEREAS, Section 8 of the aforementioned law, provides: "All claims for payment pursuant to the provisions of this Act shall, with the assistance of the local government officer concerned, be processed and settled within thirty (30) days at the nearest Government Service Insurance System branch from submission of all the required documents to the system;

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Chapter President, Liga ng mga Barangay ng Ormoc, severally seconded by City Councilors Pedro Godiardo P. Ebcas, Mario M. Rodriguez, Vincent L. Rama and Antonio M. Codilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION EARNESTLY REQUESTING THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) AND THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO IMPLEMENT REP. ACT NO. 6942, ENTITLED: "AN ACT INCREASING THE INSURANCE BENEFITS OF LOCAL GOVERNMENT OFFICIALS AND PROVIDING FUNDS THEREFOR";
