CODILLA, CITY MAYOR OF ORMOC, DATED DECEMBER 20, 2013, TO ASSIST THE SUPER TYPHOON YOLANDA-AFFECTED ORMOC CITY BUSINESS COMMUNITY.

WHEREAS, this august Body is in receipt through the Office of the City Vice-Mayor of an Indorsement from the Office of the City Mayor dated December 20, 2013, calling for its appropriate action to a Board Resolution No. 11 Series of 2013 of the Ormoc City Chamber of Commerce and Industry, Inc., (OCCCI) entitled, "REQUESTING THE LOCAL GOVERNMENT OF ORMOC CITY THROUGH THE HONORABLE MAYOR EDWARD CODILLA FOR EXTENSION OF DEADLINE TO RENEW LICENSE OR BUSINESS PERMIT IN 2014";

WHEREAS, upon perusal the said OCCCI board resolution's subject request was shown to be considerably meritorious and most deserving of this august Body's favorable action in view of the extensive damages and losses recently suffered by the Ormoc business community by reason of Super Typhoon Yolanda hitting Ormoc City on November 8, 2013 and regarded as the strongest typhoon recorded ever to have hit landfall;

WHEREAS, there comes now the urgency and need for the Ormoc City Government thru this Sanggunian to come into the assistance of the severelyaffected Ormoc business community and alleviate their unfortunate Super Typhoon Yolanda-caused business losses and problems by acceding to their request for an extension of the deadline for business licenses and permits;
