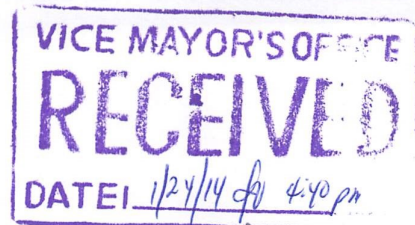

RESOLUTION NO. 2014-007

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE METRO ORMOC COMMUNITY MULTI-PURPOSE COOPERATIVE (OCCCI) FOR THE USAGE OF A SMALL PORTION OF LOT AT ORMOC CITY CEMETERY FOR THE CONSTRUCTION OF A SMALL CONCRETE VAULT AS A LABORATORY WASTE DISPOSAL SITE.

WHEREAS, this Sanggunian received an indorsement dated October 18, 2013 from the Office of the City Mayor relative to the Memorandum of Agreement (MOA) to be entered into by METRO ORMOC COMMUNITY MULTI-PURPOSE COOPERATIVE (OCCCI) with the City Government of Ormoc and further requesting that the Honorable City Mayor be granted the authority to sign the said agreement for and in behalf of the City Government;

WHEREAS, on the provision of health care program to cooperative members, the COOPERATIVE is operating a clinic/laboratory at Arradaza Street., Ormoc City, wherein it produces health care wastes;

WHEREAS, the said clinic/laboratory is required to have a septic concrete vault as its disposal site of its sharps and syringes or health care wastes in compliance with the Department of Health (DOH) license and the Department of Environment and Natural Resources (DENR) regulations;

WHEREAS, the COOPERATIVE requested the LGU- ORMOC on the usage of a small portion of lot at Ormoc City cemetery located in Barangay Can-adieng to construct the prescribed concrete vault with its specification of two (2) meters length by two(2) meters width by two (2) meters depth as sanitary disposal area for the health care wastes;

WHEREAS, this august body finds the provisions of the MOA to be in order and its implementation is subject to the terms and conditions set forth in the agreement;

WHEREFORE, on motion of City Councilor Benjamin S. Pongos, Jr., Chairman Committee on Laws & Ordinances, severally seconded by City Councilors Tomas R. Serafica, Eusebio Gerardo S. Penserga and Mario M. Rodriguez; be it

RESOLVE, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING THE CITY MAYOR, HON. EDWARD C.
