## RESOLUTION NO. 2014-011

RESOLUTION EARNESTLY URGING THE ORMOC CITY DIRECTOR OF THE PHILIPPINE NATIONAL POLICE (PNP), THE BARANGAY OFFICIALS, AND OTHER CONCERNED AGENCIES GOVERNMENT, TO PROPERLY AND STRICTLY REP ACT NO. 9211, ENTITLED: "TOBACCO IMPLEMENT. REGULATION ACT OF 2003", AND ORMOC CITY ORDINANCE 35, ENTITLED: "ANTI-SMOKING ORDINANCE OF ORMOC ESPECIALLY ON THE PROVISIONS ON PROHIBITED ACTS THEREOF, COPY OF SAID LAWS ARE HERETO ATTACHED FOR READY REFERENCE.

WHEREAS, Rep. Act No. 9211, and Ormoc City Ordinance No. 35, were enacted to give life and substance to the provision of our Constitution, Article II. Section 15, thereof, which states: "The State shall protect and promote the right to health of the people and instill health consciousness among them";

WHEREAS, the aforementioned laws have not been properly observed and implemented in our City, thereby prejudicing and endangering the health of our people, especially the non-smokers who are the primary concern of the law to be protected and safeguarded, as envisioned therein;

WHEREAS, Section 7 of Ordinance No. 35, in part provides: "Operators of public utility vehicles or tricycles-for-hire are required to post at the most conspicuous place inside their units legible "NO SMOKING VIOLATION PUNISHABLE UNDER EXISTING ORMOC CITY ORDINANCE NO. 35" sign, which requirement is not complied with in most public utility vehicles or tricycles-for-hire;

WHEREAS, it is now the hope and expectations of the members of this august body and the public in general, that the present leadership of the Philippine National Police in Ormoc City, as well as the other concerned agencies of the government, will now properly and strictly implement the aforecited laws, especially the prohibited acts provided therein;
