A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (RENEWAL) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, THROUGH THE CITY HEALTH DEPARTMENT, WITH SAN LORENZO RUIZ COLLEGE OF ORMOC, INC.(SLRC) FOR THE AFFILIATION OF ITS NURSING INTERNS.

WHEREAS, this Sanggunian received an Indorsement dated January 20, 2014 from the Office of the City Mayor regarding the renewal of the Memorandum of Agreement (MOA) to be entered into by the San Lorenzo Ruiz College of Ormoc, Inc.(SLRC) and the City Government of Ormoc, through the City Health Department, and further requesting that the Honorable City Mayor be granted the authority to sign the said agreement for and in behalf of the City Government of Ormoc;

WHEREAS, the San Lorenzo Ruiz College of Ormoc, through a letter dated January 14, 2014, requested for the renewal of MOA with the City Government of Ormoc, through the City Health Department, regarding the affiliation and training of students for Community Health Nursing of San Lorenzo Ruiz College of Nursing;

WHEREAS, said MOA refers to the continuation of the participation of Nursing Students of SLRC in providing health services to Ormoc City constituents as part of its curriculum to make the interns locally and globally competitive health workers, subject to the terms and conditions therein set forth;

WHEREAS, it can be recalled that there was a previous MOA covering the matter as embodied in SP Res. No. 2011-052 dated March 17, 2011, which duration was good for three (3) years only. In view of the coming expiration of the previous MOA, and considering that both parties still desire to continue its partnership after having acknowledged the relationship to be mutually beneficial to both the institution and the community in general, there is a need to renew the MOA concerning the matter;

WHEREAS, the said renewal of MOA covers a period of Three (3) years, to commence immediately upon the execution thereof;

WHEREAS, this august Body finds the said MOA to be in order, hence, the requested authority by the Honorable City Mayor to sign the same of given favorable consideration and due course of action;
