RESOLUTION NO. 2014-016

*A RESOLUTION RESPECTFULLY REQUESTING THE SECRETARY OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM), HON. FLORENCIO ABAD, TO CLARIFY AND/OR GIVE THE NECESSARY GUIDANCE ON THE UTILIZATION OF THE TEN PERCENT (10%) SK FUND APPROPRIATED IN THE ANNUAL BUDGETS OF BARANGAYS, CONSIDERING THAT THE SK IS NOW NON-FUNCTIONAL AS THE ELECTIONS OF SK OFFICIALS WERE CANCELLED.*

WHEREAS, in the preparation of the annual budgets of barangays, TEN PERCENT (10%) of the general fund of the barangay shall be set aside for the Sangguniang Kabataan, as required by Section 329 of the Local Government Code;

WHEREAS, the Sangguniang Kabataan as created in Section 423 of the LGC is now non-functional in view of the cancellation of the elections of its officials;

WHEREAS, the annual budgets of barangays still contain the TEN PERCENT (10%) appropriation for the Sangguniang Kabataan;

WHEREAS, as of now, there is no proper guidelines or clarification from higher or concerned authorities on how the TEN PERCENT (10%) appropriation for the SK be properly and/or legally utilized; hence, the desired clarification or guidelines thereof, is sought herein;

IN VIEW OF THE FOREGOING PREMISES, on motion of City Councilor Benjamin S. Pongos, Jr., Chairman, "Committee on Laws & Ordinances, severally seconded by City Councilors Mariano Y. Corro, Eusebio Gerardo S. Penserga, Antonio M. Codilla, Pedro Godiardo P. Ebcas, and Vincent L. Rama; be it
