## RESOLUTION NO. 2014-020

A RESOLUTION GIVING FULL SUPPORT TO THE ORMOC CITY HEALTH OFFICE'S PROGRAM OF ACTIVITIES AND IT'S REQUIRED LOGISTICAL SUPPORT TO CONTROL THE SPREAD OF DENGUE FEVER IN OUR CITY AND REQUESTING FUNDING AND LOGISTICS FROM THE CITY DISASTER RISK REDUCTION MANAGEMENT COUNCIL THROUGH ITS CHAIRMAN, THE HONORABLE CITY MAYOR EDWARD C. CODILLA.

WHEREAS, Dengue fever, a viral disease transmitted by mosquitoes is endemic in our city for the past 6 years thus causing so much morbidity and mortality;

WHEREAS, the super typhoon Yolanda has left much debris and caused much destruction in our city leaving many homes roofless thus creating more water logged areas, both situations of which are conducive to the breeding and multiplication of the mosquitoes;

WHEREAS, this present environment has resulted to the increase in the incidence of dengue fever in our city beyond outbreak proportions to the threshold of an impending epidemic;

WHEREAS, the City Health Department has carried out a lot of activities to control the spread of the disease in our city through the control of the mosquitoes like the activation of the Barangay Dengue Brigade to conduct search and destroy of the mosquitoes and their breeding places, the application of larvaecides to all water logged areas, fogging to destroy the adult mosquitoes and other cleanliness advocacies;

WHEREAS, many NGOs have rendered help to our city in this fight against Dengue, like the Rotary International has donated the larvaecides, the UNDP (United Nations Development Program) has deployed 800 people for 15 days to clear out the debris, the MSF (Doctors without Frontiers) and the Korean Community in the Philippines has donated fogging machines;

WHEREAS, the City Health Department still needs assistance in this very important endeavor of controlling this Dengue outbreak in our city like the hiring of an additional 100 people for 15 days to conduct cleanliness drives at the total cost of P300,000.00 and the purchase of additional 200 kilos of larvaecide (Temephos at P550.00 per kilo) at the total cost of P110,000.00 for a grand total cost of the program at P410,000.00;

WHEREFORE, on joint motion of City Councilors Mario M. Rodriguez, Chairman, Committee on Health, and Pedro Godiardo P. Ebcas, Chairman, Committee on Public Safety, severally seconded by City Councilors Tomas R. Serafica, Mariano Y. Corro and Ruben R. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GIVING FULL SUPPORT TO THE ORMOC CITY HEALTH OFFICE'S PROGRAM OF ACTIVITIES AND IT'S REQUIRED LOGISTICAL SUPPORT TO CONTROL THE SPREAD OF DENGUE FEVER IN OUR CITY AND REQUESTING FUNDING AND LOGISTICS FROM THE CITY DISASTER RISK REDUCTION MANAGEMENT COUNCIL THROUGH ITS CHAIRMAN, THE HONORABLE CITY MAYOR EDWARD C. CODILLA;
