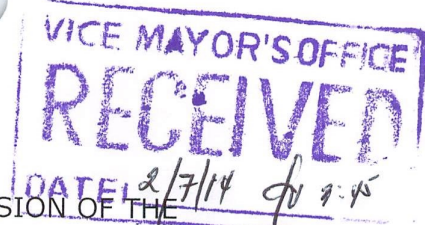

*A RESOLUTION REITERATING FULL SUPPORT TO THE
PROJECT- CONSTRUCTION OF A 30-MEGAWATT SOLAR
POWER PLANT IN BARANGAY DOLORES, ORMOC CITY- BY
THE PHILIPPINE SOLAR FARM-LEYTE, INC. (PSFLI).*

WHEREAS, the proposed 30-Megawatt Solar Power Plant project of Philippine Solar Farm- Leyte, Inc. (PSFLI) in Brgy. Dolores, Ormoc City is another milestone in the development and progress of the City of Ormoc;

WHEREAS, not only will the project help stabilize the city's coffers through future business taxes and other fees, it is also expected to boost the tourism industry and employment of the city;

WHEREAS, it can be recalled that a similar resolution expressing support to the said Solar Power Plant project has been passed by the previous sanggunian as embodied in SP Res. No. 2013-086 dated May 23, 2013;
