*A RESOLUTION DECLARING THAT TAX ORDINANCE NO. 2014-001 OF BARANGAY DISTRICT XIII, THIS CITY, ENTITLED "2014 TAX ORDINANCE OF BARANGAY DISTRICT XIII, ORMOC CITY" UNDER REVIEW HAS BEEN FOUND TO BE IN CONFORMITY WITH EXISTING LAWS AND CITY ORDINANCES, AND INTERPOSING NO OBJECTION TO THE IMPLEMENTATION THEREOF.*

WHEREAS, this Sanggunian was in receipt of Tax Ordinance No. 2014-001 of Barangay District XIII, entitled: "2014 TAX ORDINANCE OF BARANGAY DISTRICT XIII, THIS CITY."

WHEREAS, the afore-cited ordinance was submitted to the august Body in pursuance of its review powers over enacted barangay ordinances within its territory as provided for in Section 57 of Republic Act 7160, otherwise known as the Local Government Code of 1991.


