## RESOLUTION NO. 2014-034

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CODILLA TO ENTER INTO AND SIGN A EDWARD MENORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT AGRICULTURE-NATIONAL MEAT INSPECTION SERVICE (DA-NMIS), **FOR** THE MRLEMENTATION OF THE RECONSTRUCTION OF ORMOG CITY SLAUGHTERHOUSE.

WHEREAS, an Urgent Indorsement was received by this august Body dated February 14, 2014 from the Office of the City Mayor relative to the Memorandum of Agreement to be entered into by the Department of Agriculture-National Meat Inspection Service (DA-NMIS) with the City Government of Ormoc, and further requesting that the Honorable City Mayor be granted the authority to sign the said agreement for and in behalf of the City Government of Ormoc;

WHEREAS, the super typhoon Yolanda caused extensive devastation and death in some part of the regions in Central Philippines that instigate huge damage and loses in agriculture and fisheries, business establishments, as well as government facilities and other infrastructure;

WHEREAS, in Ormoc City one of the heavily damaged government infrastructure which was caused by Typhoon Yolanda was the City's Slaughterhouse;

WHEREAS, the Department of Agriculture through its Regional Field Offices (RFO), Bureaus, attached agencies and corporations, in support for the Reconstruction Assistance for Yolanda (RAY) Plan of the National Government, is providing funds for the reconstruction of the NMIS Regional Technical Operations Center and the repair/reconstruction of slaughterhouses as an intervention to assist the Yolanda affected areas;

WHEREAS, the NMIS as trustee, is tasked to handle and manage the DA funds for the implementation of the reconstruction of the NMIS Regional Technical Operations Center and the repair/reconstruction of slaughterhouses;

WHEREAS; LGU-Ormoc is identified by the DA to be a beneficiary of financial assistance for the slaughterhouse reconstruction;

WHEREAS, considering that the Ormoc City Slaughterhouse is one of the primary facility that will help boost the economic activities in the city, there is a need for the immediate implementation of the repair/reconstruction of the same in accordance with the terms and conditions set forth in the agreement:

WHEREAS, this august Body finds the agreement to be beneficial to the City of Ormoc hence, the requested authority for Honorable City Mayor to sign the same is deserving of affirmative action;

WHEREFORE, on motion of SP Member Tomas R. Serafica, Chairman, Committee on Agriculture and Fisheries, severally seconded by SP Members Mario M. Rodriguez, Pedro Godiardo P. Ebcas and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF AGRICULTURE-NATIONAL MEAT INSPECTION SERVICE (DA-NMIS), FOR THE IMPLEMENTATION OF THE RECONSTRUCTION OF THE ORMOC CITY SLAUGHTERHOUSE;
