AN OMNIBUS RESOLUTION AUTHORIZING THE HONORABLE  
CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND  
SIGN THE MEMORANDA OF UNDERSTANDING (MOU) BY  
AND BETWEEN THE CITY GOVERNMENT OF ORMOC AND  
THE MEDECINS DU MONDE FRANCE (MdM-F),  
REPRESENTED IN THE PHILIPPINES BY MS. ASTRID  
HECKMANN, GENERAL COORDINATOR OF MdM- FRANCE,  
COVERING THE REHABILITATION OF THE FOLLOWING  
BARANGAY HEALTH STATIONS, TO WIT:

- 4.) MAHAYAHAY HEALTH STATION, IPIL DISTRICT, ORMOC CITY.
- 5.) QUEZON JR. HEALTH STATION, IPIL DISTRICT, ORMOC CITY.
- 6.) MACABUG HEALTH STATION, IPIL DISTRICT, ORMOC CITY.
- 7.) HUGPA HEALTH STATION, IPIL DISTRICT, ORMOC CITY.

WHEREAS, the 13<sup>th</sup> Sangguniang Panlungsod ng Ormoc received an Urgent Indorsement dated February 17, 2014 in connection with the Memoranda of Understanding to be executed by and between the CITY GOVERNMENT OF ORMOC, represented by the City Mayor Edward C. Codilla and the MEDECINS DU MONDE FRANCE (MdM-F), represented in the Philippines by Ms. Astrid Heckmann, General Coordinator of MdM-F;

WHEREAS, in the same indorsement it is further requested that the Honorable City Mayor be granted the authority to sign the said MOU covering the rehabilitation of the above-enumerated barangay health stations in Ormoc City for and in behalf of the City Government of Ormoc;

WHEREAS, MdM-F is an international humanitarian, impartial and independent organization providing medical care for the most vulnerable population through 151 programs in 64 countries affected by armed conflicts, internal violence, natural disasters, disease, famine, poverty or exclusion;

WHEREAS, being a non-government medical humanitarian organization, MdM-F in the Philippines is running a project aiming at contributing, in Four (4) years, to the mitigation of sanitary and environmental consequences of electronic and electrical waste informal recycling in urban poor communities;

WHEREAS, considering the extensive damage of Typhoon Haiyan/Yolanda, MdM-F launched an emergency response program last November 10, 2013, to assist the affected population communities;

WHEREAS, in view of the devastation to major government buildings and infrastructures in the aftermath of Super Typhoon Haiyan/Yolanda in Ormoc City, MdM-F manifest their intention to support the City Health Office of Ormoc in the Rehabilitation of damaged health facilities hence, the purpose of this understanding;

WHEREAS, the objective of the MOU is the rehabilitation of Seven(7) health facilities in Ormoc City, damaged by the typhoon Yolanda, in order to facilitate the population access to health care, to be rehabilitated by the MdM-F in its condition prior to the typhoon with no structural changes or specific reinforcement to be done;

WHEREAS, both parties mutually agreed to collaborate for the rehabilitation of said Health Stations subject to the specific obligations of the concerned parties as stipulated therein;

WHEREFORE, on motion of SP Member Mario M. Rodriguez, Chairman, Committee on Health & Sanitation, severally seconded by SP Members Vincent L. Rama, Ruben R. Capahi, Tomas R. Serafica, Pedro Godiardo P. Ebcas and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass an OMNIBUS RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. 
